Hello everyone,

Recently, I attended an event where a panelist shared their frustration with current conversations about sustainability in agriculture. At first, I was a bit caught off guard by the remarks. 



ACQUIRING ENVIRONMENTAL ALLIES: INCREASING THE ADOPTION OF ENVIRONMENTAL STEWARDSHIP PRACTICES BY ONTARIO LANDOWNERS





As societal pressures around environmental stewardship increase and Canada

Management experts and scholars view sustainability through the triple-bottom-line, recognizing there is a balance between achieving environmental, economic and societal goals. Government and Industry will benefit from recognizing and promoting the triple-bottom-line to primary producers to help increase the adoption of agri-environmental programming.

This project sought to improve our understanding of how landowners could be engaged to participate and improve the environmental stewardship of their lands by studying the adoption of environmental stewardship practices in other jurisdictions and farm business management best practices.

The research reveals a number of opportunities to increase the participation of landowners in agri-environmental programming. The recommendations derived from this research are presented in three (3) distinct categories: Policy and Programming, Communication Tactics and Strategies, and Future Research.

AgriShield is the first and only risk management platform in Canada that meets the Farm Sustainability Assessment (FSA) standard at the highest level – **GOLD.**

The FSA was developed by the Sustainable Agriculture Initiative (SAI), an internationally recognized sustainability standard dedicated to advancing sustainable agriculture across the food and beverage value chain. Over 150 companies in over 30 countries including Canada are using the FSA tool to support their sustainable sourcing goals. These companies include Nestle, Cargill, Bayer, Syngenta, Bonduelle, Kellogg's, McDonald's, OceanSpray, and McCain. FSA is used to evaluate the level of on-farm sustainability and encourage continuous farm improvement in economic viability, social responsibility, and environmental stewardship.

ROOTS TO SUCCESS: A COMPREHENSIVE APPROACH TO MANAGING FARM RISK

The Roots to Success project has made meaningful progress towards improved risk management for the agriculture and agri-food sector by providing farmers and consultants working directly with farmers with much-needed training to identify and assess risks and create comprehensive risk management plans.

Over the course of the project, Farm Management Canada offered 40 workshops to farmers and advisors. These workshops guided participants through a comprehensive risk management assessment and planning process using AgriShield platform, enabling them to continue their work in the months that followed. Students in agricultural colleges in universities all across Canada were also trained on managing farm risk and the AgriShield platform, and a national promotional campaign helped to inform the Canadian agricultural sector about the best practices, tools and resources available to help increase farmer and farm resilience.

Now that the CAP has come to an end, Farm Management Canada hopes to continue to improve risk management for the agriculture and agri-food sector through the Sustainable Canadian Agricultural Partnership (Sustainable CAP). Through the AgriCompetitiveness program, Farm Management Canada has applied for funding to conduct a series of focus groups aimed at reviewing the risk management needs of farmers, resources and tools available, their use and impact, and opportunities for new knowledge resources and tools. A National Risk Management Advisory Committee would also be established to work towards the development of a National Risk Management Education and Communication Strategy.

And, workshops will continue to be delivered using the AgriShield platform to help farmers establish a comprehensive approach to risk assessment and planning including how to optimize the use of government BRM programs

AGRIRESPONSE – A WAY TO MEET ALL YOUR RISK MANAGEMENT NEEDS

Recent events like COVID-19, supply disruptions, inflation and increased interest rates have highlighted the importance of being prepared for change, to increase the capacity to build resilience of our farms, and to not only be ready to face the challenges ahead, but to be ready to seize the opportunities that may present themselves along the way.

The AgriResponse website provides access to expert advice, resources and tools to support risk preparedness and management.

Here are excerpts from two articles that were posted since our last newsletter:

Post-pandemic inflation and the need for on-farm financial management

As the world recovered from the pandemic, surges in demand led to shortages in supply, which were exacerbated by several events, including Russia's invasion of Ukraine, domestic and international political tensions, and the increasing urgency for climate action resulting in new policies, targets, and practices. The result of this [im]perfect storm is the current inflation we are experiencing, which went from -0.4% in January 2022 to 8.1% in June 2022. Moreover, inflation has been made more complex by the emergence of new price drivers, such as fossilflation, greenflation, and climateflation, which had already begun to impact economies around the world amidst the urgency of ensuring an effective and timely net-zero transition.

Global supply chain conditions are changing, with China at the centre: What will this mean for Canadian farmers?

China is home to nearly 1.5 billion people and is the world's second largest economy, valued at USD\$17.74 trillion in 2021. Canada's agri-food exports to China represented almost CAD\$9.4 billion in 2020, an increase of 43.3% from 2019. While China's continued growth has been beneficial for exporters and significantly alleviated its domestic poverty rates metrics, the pace of its growth has also left some behind. Moreover, while its historical growth rate has been quite high, its potential growth may slow, with trade implications for exporters like Canada. These implications may be compounded by an increasingly inward-facing approach to development, as well as several key structural factors, including access to food, energy, and healthcare; an ageing population; and food security concerns. Due to the nature of today's global supply chain, any instability in China has potential risks for its trade partners.

SUMMARY REPORT

Results of targeted discussions held during the 2023 National Agriculture Risk Management Forum



The Risk Management Forum and subsequent Report was funded in part through Agriculture and Agri-Food Canada's AgriRisk Initiatives Program.

A National Agriculture Risk Management Forum was hosted by Farm Management Canada in Ottawa February 16–17, 2023.

The objective of the Forum was to identify the impacts of actual, emergent, and potential risks and opportunities for agriculture to establish a path forward and make meaningful progress in building on-farm risk resilience and the build capacity for Canada's farmers to seize new opportunities.

The Forum brought together key representatives from different parts of the agriculture sector including academia, advisors, industry associations, lenders, producers, provincial governments and retailers.

A comprehensive summary report titled "Building Farm Financial Resilience" is now available at: fmc-gac.com/programs-services/research-analysis/#risk-management.

The Report contains key messages and recommendations identifying roles and responsibilities for key players within Canada's agricultural sector. Recommendations include:

- Create a national risk management education and communication strategy for producers.
- Demonstrate the connection between sustainability, resilience and risk management to increase the understanding of the practical benefits for farmers.
- Undertake greater collaboration with farmers when designing farming policies and programs like the Sustainable Agricultural Policy.
- Coordinate and expand farm financial literacy and risk management training.
- Standardize farm financial statements and streamline farm financial reporting.
- Encourage producer groups and farm organizations to prioritize, invest in, and coordinate risk management training and education.
- Identify gaps in agricultural research and development of new technologies to support emerging risks.
- Invest in mental health programming that caters to the unique needs of farmers.
- Prioritize investments into high-speed internet to ensure rural communities have access to educational programming and resources.

Every two years, the International Farm Management Association (IFMA) selects a country to host its International Farm Management Congress. Canada has been selected to host the 2024 Congress in Saskatoon, Saskatchewan in partnership with Farm Management Canada and the College of Agricultural and Resource Economics at the University of Saskatchewan. The Congress provides a unique and most enjoyable way to travel to different parts of the world, to learn about the local agriculture, to meet people of like mind – both in an international and a local context, to form international relationships of mutual benefit, to learn something about the local and national heritage, to taste local food and drink and to altogether have a thoroughly rewarding learning and networking experience.

The first IFMA congress was held in the United Kingdom in 1971.

Each congress lasts 6 days and normally attracts 400 participants from all continents. The plenary program is run over the course of three days (Monday, Wednesday and Friday) and includes a mixture of keynote presentations and discussion panels with invited speakers and concurrent contributed paper and poster sessions.

Interspersed with the plenary program, for two days of the Congress (Tuesday and Thursday), delegates participate in field trips to various farms, as well as research, agribusiness and educational facilities in the local area.

Pre- and post- Congress tours, usually of a week's duration, are organized to give participants the opportunity to see much more of the host country's agriculture and heritage. And a comprehensive and diverse partners' program is offered, and a varied and enjoyable social program is also included in each Congress.




